An Analysis - 2019

Of the 116 complaints that were considered by the Media Council in 2019 12 were upheld in full; six were upheld by a majority; eight were upheld in part; seven were part upheld by a majority; five were not upheld by a majority; and 58 were not upheld. Twenty-one complaints were ruled insufficient grounds to proceed. A further 18 complaints were resolved informally.

Forty-five complaints were against daily newspapers; three were against weekend newspapers; six were against community newspapers; 37 were against online news sites; one was against magazines and 24 were against broadcasters.

Most complaints going to adjudication are considered by the full Council. However, on occasions, there may be a complaint against a publication for which a member works, has had some input into the complaint or has some link. On these occasions the member takes no part in the consideration of the complaint. Likewise, occasionally a Council member declares a personal interest in a complaint and leaves the meeting while that complaint is under consideration. In 2019 there were 18 occasions where a member declared an interest and left the room while the complaint was considered. There were also eight occasions when an industry member was required to stand down to maintain the public member majority.

Debate on some complaints can be quite vigorous and while the majority of Council decisions are unanimous, occasionally one or more members might ask that a dissent be simply recorded, or written up as a dissenting opinion. In 2019 18 cases involved a dissent (Cases 2764, 2765, 2773, 2775, 2796, 2797, 2798, 2799, 2800, 2804, 2805, 2808, 2809, 2810, 2811, 2814, 2825, 2855)

Media Council complaints are generally considered on the papers. However if a complainant requests the opportunity to make a submission in person they are generally given that opportunity. In such cases the editor is also invited to attend. No new material ie that has not already been presented to the editor for a response may be introduced at this stage. This year one complainant asked to attend the meeting.

The Media Council does not encourage legal representation, the Council is after all dealing with ethical issues not legal ones, but occasionally complainants do attend with or are represented by their lawyers. One lawyer appeared in 2019 on Case 2854.

The Media Council has a fast-track process which is mostly used around the time of General or Local Body Elections. However it can be utilised at any time if the Chair determines a complaint would benefit from a quick resolution. The Council received 144 complaints about a cartoon published in the Otago Daily Times on December 3. Had the complaint followed the usual process it would not have been considered until February the following year. With co-operation from the editor the Council was able to consider five representative complaints at the December meeting and the ruling, upholding the complaints, was released just before Christmas.

NOTES TO THE FINANCIAL STATEMENTS

New Zealand Media Association Incorporated For the year ended 31 December 2019

1. Reporting Entity

The New Zealand Press Council is incorporated under the Incorporated Societies Act 1908, and is a Non Governmental Organisation which exists to uphold standards in the New Zealand print media and promote freedom of speech in New Zealand.

Basis of Preparation

These financial statements have been prepared in accordance with the Special Purpose Framework for use by For-Profit Entities (SPFR for FPEs) published by Chartered Accountants Australia and New Zealand.

The financial statements have been prepared for taxation purposes

Basis of Preparation for the 2019 Year

For periods up to and including the 2019 financial year, The New Zealand Press Council prepared its financial statements in accordance with approved Financial Reporting Standards (FRSs) and Statements of Standards Accounting Practice (SSAPs) as appropriate for entities that qualified and applied for New Zealand differential reporting concessions. The financial statements for the year ended 31 December 2019 have been prepared in accordance with SPFR for FPE which is not New Zealand Generally Accepted Accounting Practice (NZ GAAP).

Historical Cost

These financial statements have been prepared on a historical cost basis. The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Income Tax

The Income Tax liability is limited to Interest Revenue only, less a \$1,000 exemption granted by Inland Revenue. The liability is charged to the Profit and Loss statement in accordance with the income tax return to Inland Revenue.

Goods and Services Tax

All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.
